Hi, my name is Jon Friedl. Welcome to Professor Slots, a channel that's all about mastering casino slots so you can win your way to success. If you've ever walked into a casino, looked around, and wondered what's going on with slots, I can help.

As of about an hour ago, 227 U.S. casinos have re-opened and 762 remain closed. Many casinos have started to open in the last week, with quite a few more planning to open in June, which starts tomorrow. During our last show a week ago, 162 casino properties have re-opened while 827 remain closed. With another 62 casinos in the last week, we're up to 6.5% of all U.S. casinos having re-opened.

Where am I getting this current information? Well, the American Gaming Association has created a live casino tracker on their website. To get to it, here's a convenient like I've created: ProfessorSlots.com/tracker.

As I'd also mentioned on my last live stream, perhaps you're wondering what it's like at a re-opened or about-to-be-re-opened casino? For re-opening plans for casinos in your area as well as interactive casino trip reports from your local slots enthusiasts, some of whom you may know, be sure to join one of my private slots communities on Facebook. I've got one for every state as well as one more for every state called Professor Slots Enthusiasts. Oh, and last bit of business. As you have requested, I've created a Professor Slots apparel and other merchandise shop. The clothing has it both on the front in small font as well as across the back because, of course, that's about people can see when you're sitting a slot machine in a casino. I have some items on order, and will probably wear them once they arrive.

Their links are sandwiched between links to my Start Here and my Personal Coaching pages.

I'll review Assessing Casinos for Success today and well as covering why you need to do this now. It's a generally useful tool and, frankly, a necessary assessment to be performed at least once a year by every slots enthusiast.

Besides annually, it's needed after a casino has changed ownership, had any significant renovation, and more. When think about how to best help slots enthusiasts through this unique time, I realized that a national crisis where all casinos suddenly closed and, after over two months, are now slowly re-opening.

It's not just that casinos might have taken those two months to make some serious renovations to their properties, but that all casinos have make changes to accommodate safety precautions. So, let's get to it.

Casino Re-Assessments Live | North Carolina Slots in 2020

It covers Keep in mind these assessments are individualized.

What you want from a casino isn't necessary what someone else wants. That's why YOU, or someone who knows you very well indeed, need to do the assessment. We've seen some of this misunderstanding in the slots communities, where members report what was important to them but other members reading the casino report later often have questions. Like, didn't you go into (or leave) the high-limit room? Why ever not??

One of the tools offered by the article is a free checklist for performing a physical assessment of a casino. It's a one-page pdf with 25 questions you should try to answer when performing a casino assessment. You can download the checklist by filling out red/green form near the bottom of the article.

A physical assessment isn't everything involved with assessing casino, but it is a crucial last element. First you need to review it online before deciding to take the time to visit it. Is this starting to sound familiar?

Introduction

This is the second segment of the show on slot machine casino gambling. Here, I provide a brief overview of the current state of gambling in a U.S. state, territory, or the federal district emphasizing, by far, anything of interest to slot machine casino gamblers.

Up next is North Carolina slot machine casino gambling in 2020. Here goes!

North Carolina slot machine casino gambling consists of two tribal casinos in the Great Smoky Mountains in the western tip of the state.

Tribal-state gaming compacts in North Carolina have established theoretical minimum and maximum payout for their video gaming machines while return statistics are not publicly available.

Relevant Legal Statutes on Gambling in North Carolina

The minimum legal gambling age in North Carolina depends upon the gambling activity:

- Land-Based Casinos: 21
- Poker Rooms: 21
- Bingo: 18
- Lottery: 18
- Pari-Mutuel Wagering: Not available

Video poker machines were once widespread in the state, but 2000's state regulations limited video poker machines to three per site and banned the installation of new video gaming machines.

In 2007, after nearly a half dozen attempts, the state legislature fully banned commercially-owned video poker machines and video gaming machines.

North Carolina has a single federally-recognized American Indian tribe, the Eastern Band of Cherokee Indians. The tribe has built two casinos on its Qualla Boundary lands located in the Great Smoky Mountains.

The type of casino action found at these Indian casinos includes "skill or dexterity" based video slot machines. These tribal casinos offer a variety of table games.

Although owned by the tribe, operation of both casinos is by Harrah's which, itself, is a brand for Caesars Entertainment. The tribe owns and operates a high-stakes bingo hall.

Slot Machine Private Ownership in North Carolina

Next up is a usually short statement about slot machine private ownership, which I have included in case you live in this U.S. state and are considering owning a slot machine. Here it is:

In North Carolina, it is legal to own a slot machine privately if it is 25 years old or older.

Gaming Control Board in North Carolina

Because North Carolina has no commercial casinos or other types of commercial gaming, the state does not have a gaming commission or control board.

Casinos in North Carolina

In this section, I'll discuss North Carolina gambling establishments.

There are two American Indian tribal casinos in North Carolina. These two casinos are in the Great Smoky Mountains in the western part of the state. There are no commercial casinos in the state.

The largest casino in North Carolina is Harrah's Cherokee Casino Resort with 3,280 gaming machines. Harrah's Cherokee is in Whittier found 50 miles west of Asheville.

The second-largest, and only other casino in North Carolina, is Harrah's Cherokee Valley River Casino & Hotel with 1,000 gaming machines. Harrah's Cherokee Valley River is in Murphy found 109 miles southwest of Asheville.

Other Gambling Establishments

As an alternative to enjoying *North Carolina slot machine casino gambling*, consider exploring casino options in a nearby state. Bordering North Carolina is:

- North: Virginia
- East: The Atlantic Ocean
- South: Georgia and South Carolina
- West: Tennessee

Payout Returns in North Carolina

The theoretical minimum and maximum payouts set by the tribal-state gaming compact is 83% and 98%. The tribal casinos in North Carolina, per the same compact, are not required to provide publicly available return statistics.

Summary of North Carolina Slots in 2020

In summary, North Carolina slot machine casino gambling consists of two tribal casinos in the western tip of the state. While owned by the Eastern Band of Cherokee Indians, Caesars Entertainment operates both tribal casinos.

Further, both tribal casinos have theoretical payout limits of 83% and 98% but do not offer return statistics. Finally, North Carolina's slot machines must be video games of skill or dexterity.

Annual Progress in North Carolina Slot Machine Casino Gambling

Over the last year, there has been no change in the slots gaming industry in North Carolina, excepting disruptions due to our ongoing national crisis.
