Introduction to [Guam Slot Machine Casino Gambling 2017](#)

Guam slot machine casino gambling is not available on this unincorporated U.S. island territory situated in Micronesia in the Western Pacific. Guam consists of 210 square miles of land with 162,742 residents as of 2017. The most populous city is Dededo. Its capital is Hagatna.

Guam is the largest and southernmost of the Mariana Islands and the largest island in Micronesia. Since the 1960s, Guam's economy, stable since 2000, has been supported by tourism and the United States Arms Forces.

Guam is a popular tourist destination, with 90% being Japanese. Flight time from Japan is 3 hours. The remaining tourists are from South Korea, the United States, the Philippines, and Taiwan.

The city of Tumon is the hub of GU tourism, having:

- over 20 large hotels
- duty-free shopping
- Pleasure Island district
- indoor aquarium
- Sandcastle Vegas-style shows
- other shopping and entertainment venues

Guam's seven golf courses accommodate over a million tourists per year.

Relevant Legal Statutes on Gambling*

Most forms of gambling are illegal, including casinos and slot machines. Gambling is illegal due to the Criminal and Correctional Code from 1977. Betting on greyhound racing, however, is allowed.

Guam's Criminal and Correctional Code contains [Chapter 64: Gambling](#) under the Supreme Court of Guam's Compiler of Laws.

Slot Machine Private Ownership

The possession of gambling devices is illegal, regardless of whether or not the devices are operational.

Gaming Control Board in Guam

In 1996, voters were asked to decide whether or not to legalize casino gambling in the island. Voters defeated it by an almost three-to-one margin.

In November of 2004, voters were again asked to decide. This 2004 initiative would have restricted casinos to hotels with more than 100 rooms. The proposal was voted down by a wide margin, primarily by the Catholic Church and assorted business leaders.

Further, in June of 2006, Governor Felix Camacho reversed a decision to allow casino gambling during the yearly Liberation Day carnival commemorating the liberation of the island from the

Japanese during World War II.

Several additional attempts have since been made to legalize gambling, primarily focused on installing slot machines at the Guam Greyhound track. All such proposals were defeated by voters.

In November of 2008, the Guam Greyhound Park closed after 32 years of operation.

Casinos in Guam

Most forms of gambling are illegal. However, game rooms and pachinko parlors can be found, but are not classified as gambling.

Despite the conclusion of the annual Liberation Carnival in August of 2016, the Mayors' Council of GU has continued to use the casino building at the Tiyan carnival grounds for gambling events using the name of village fiestas as recently as March 24, 2017. Read the [full report](#).
